Slide 3: Report by Chair of Trustees Denise Jackson MBE.

DJ opened her Report by recognising the challenges that the pandemic has brought to our ACSR and our community. GS shared two documents relating to ACSR 'Journey' from 2012 and also ACSR revised Organisational Structure as per our successful grant application to the National Lotteries Communities Fund to fund a three post for a Development Manager.

A question was asked in relation to this funding the former ACSR Sports Hub WG, which is now independent of ACSR and awaiting confirmation of charitable status.

Slides 4-10: ACSR 2019/2020 Financial Report:

- Income and expenditure showing £5487.00 overspend which was grant funding already held within accounts from 2018/19
- Income and expenditure by subgroups / Working Groups, with special mention of The Sports Hub income and expenditure. SC commented on funds still held that are committed to various projects that are currently in abeyance due to CV-19
- Donations and grants received
- Bank balance at 31 March 2020.
- Future funding initiatives this included our successful application for £104K to employ a Development Manager for the charity.

Accounts were accepted and **Proposed** by Dan Kipps and **Seconded** by Steven Watt.

Bill Campbell retired as a Trustee in April. Bill was one of the founder Members of the original Community Sports Hub and has committed many years for sport within our community.
